## *August 2016 Monthly Report Summary*

### **COMMUNITY EVENTS:**

August in Fort Thomas means that our kids return to school. The Police and Fire Departments along with faculty and staff from the schools, participated in State mandated exercises for fire, tornado and emergency lockdown drills.

### **TRAINING:**

Chief Mike Daly attended the annual Kentucky Association of Chiefs of Police Conference, held in Bowling Green, Kentucky. This conference brought in Police Chiefs and command staff officers from across the Commonwealth. The theme of this year's conference was "Being Resilient in Today's Times". Several blocks of training were offered including: Emotional Survival for Law Enforcement; Response to Active Shooter Events; The Will to Survive, Dealing with the Aftermath of Trauma; and the Banquet with guest speaker Honorable Davis Hale, US District Judge of the Western District of Kentucky. Over 100 officers were in attendance, making this conference a very successful place to exchange ideas and network with other police leaders. In addition to training, the association presented several agencies with their five year accreditation certificate, which shows that those agencies have met all of the requirements to be a state-accredited police agency.

Sergeant Chris Carpenter and Officers Doug Bryant and Michael Dietz attended the National Tactical Officers Association Conference in Louisville. The conference included several debriefed incidents involving recent active shooter events and terrorist attacks from around the world by people that were there. The conference also included several classes such as Tactical Tracking and Wooded Terrain and Tactical Pistol.

Officer Adam Peak attended Vehicle Collision Investigation Course Level II for two weeks taught through the Kentucky State Police in Frankfort, KY. The course focused on what happens at the point of impact including maximum engagement, separation, and post impact analysis. The course also included occupant kinematics or rather, how people move inside of vehicles during collisions. At the conclusion of Level II, investigators were able to build a complete timeline for time, distance, speed, and energy used throughout an entire collision event. This includes beginning at the point of possible perception, all skid surfaces or surfaces crossed, the actual

collision event, post impact events, all the way through the final resting spot of the vehicles involved. Having the information, formulas, and knowledge to assess the incident for all areas of the collision helps investigators in determining human factors, vehicle factors, and environmental factors that contributed to the entire collision. Thus forming a fact based determination of fault which will help the victim's families and court proceedings to understand exactly what took place during a collision

## RECOGNITION:

The entire department received a thank you note from the residents at 3 N Shaw Lane. They wrote to express their gratitude for the protection and service the department provides.



An executive order appointing William Hunt as a Sergeant for the Fort Thomas Police Department was approved by City Council on August 15, 2016. William has been with the department since 2003. William has worked with the Crime Scene Team, FTO, and assisted with the CSI class at Highlands Middle School as well as being available to the community, schools and businesses. Pictured with William are his wife Kelly and his sons William, Davis and Walker. His wife Kelly states she and their boys are very proud to stand behind him and the badge, and they have a hero all the time.



After 21 years of service, Sergeant Chris Goshorn retired from the Fort Thomas Police Department on July 31, 2016. Chief Mike Daly says of his 21 plus years of working with Chris, the biggest thing that describes Chris is compassion. He is one of the most compassionate officers that he has ever been around. Chris was raised in Fort Thomas. He attended Woodfill Elementary and graduated from Highlands and then from NKU. He has raised his children here. He is deeply rooted and committed to the community and feels obligated to make it as good a place as he can. He extends a thank you to the community for giving him the opportunity to service and protect and for being part of his life. Chris is holding a farewell gift from fellow officers.

## ENFORCEMENT:

In August officers wrote 23 speeding charges, 3 DUI charges, 32 charges for non-traffic offenses (i.e., warrants, assaults, disorderly conduct, etc.) and 83 traffic charges (i.e., suspended OL, no insurance, expired license plate, etc.) Officers also issued 93 written warnings and totaled 23 court appearances. There were 12 drug related charges placed against 7 adults and 3 drug charges placed against two juveniles. One of the individuals is a Fort Thomas resident. Traffic stops led to 9 of the charges.

*(Information as of September 14th, 2016)*



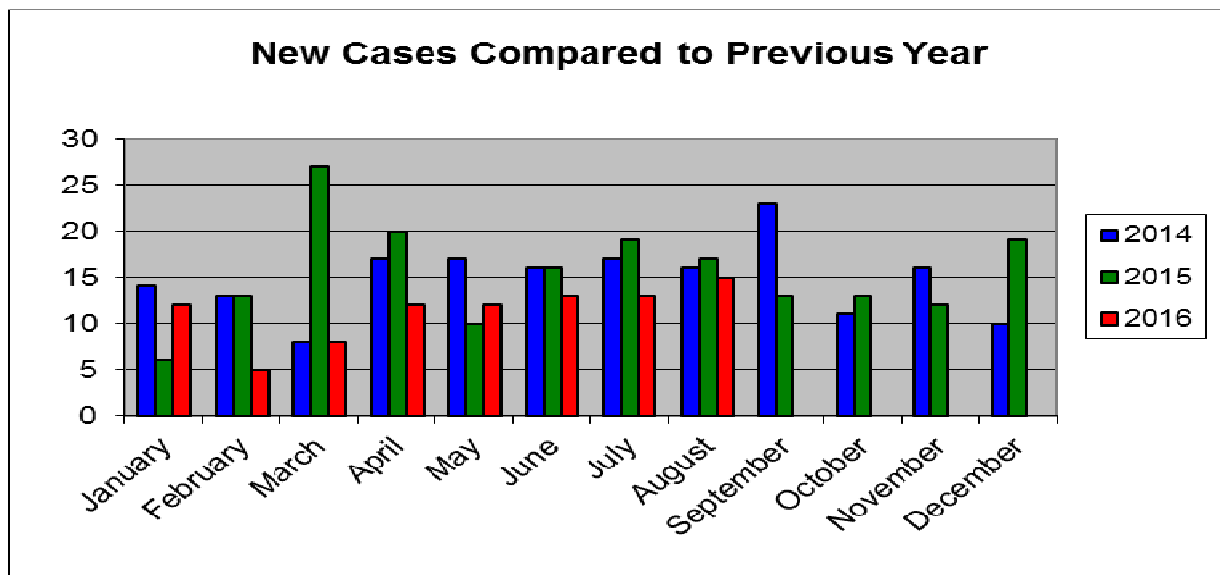

### Investigation Updates

- During the month of August our Detectives have been working hard to identify the subject(s) responsible for the numerous car break-ins throughout the city. Through their investigations, they have identified three individuals who are believed to be responsible. Our Detectives are continuing to conduct interviews and locate these subjects in hopes that charges will be forthcoming.
- In late August, shortly after the beginning of school, a juvenile was found to be in possession of a firearm at the High School. With the work of school officials and responding officers the subject was identified, removed and the threat had been eliminated without incident. We continue to applaud those students who brought this information to school staff to prevent any potential incident.
