February 2019 Monthly Report Summary

COMMUNITY EVENTS:

School Resource Officer Zac Rohlfer spoke to Ruth Moyer's fifth grade students regarding the Bill of Rights. The students have been discussing this in class. The students asked Officer Rohlfer questions they had relating to real life situations. Officer Rohlfer was impressed with not only the amount of questions they had but the time and effort they put into researching proper questions regarding this topic.

TRAINING:

Chief Casey Kilgore, Sergeant Adam Noe and Detective Micheal Rowland attended ***Managing your Basic Life and Career Class***. This class encompasses job issues, goals, personal health, The Kentucky Retirement System itself, post retirement legal and financial issues and how to look for new work. This course is designed as a primer for learning how to manage your family and financial needs. Students will learn the importance of career goals and discuss why it is important to have a life outside of law enforcement. Students will learn about retirement benefits and options and how staying or retiring may affect them and their families. Students will also learn about issues involving wills, powers of attorney along with social security issues and tax issues that could impact them financially. And finally, students will look at issues regarding reemployment in regard to resumes and interviewing.

Sergeant Nathan Day and Detective Derek Faught attended ***Officer Safety and Wellness Training***. This training inspired mid-level law enforcement leaders to advance officer safety and wellness strategies within their own agencies. Topics included: addressing leadership strategies; examining causes of officer assaults, injuries, and deaths; exploring critical officer wellness issues; discussing protocols and best practices; discussing setting a safety precedent and accountability; and illustrating actionable opportunities to increase safety and wellness.

Officers completed CPR and First Aid Training.

RECOGNITION:

The department received a thank you note from the Fort Thomas Moms Club. They wrote to thank us for our continued support to their organization and our participation in their second successful expo. They were able to donate \$1,200.00 to The Care Closet.

Officer Brandon Laffin was presented the Fort Thomas Police Life Saving Award at the February City Council Meeting. On October 25, 2018, our officers were dispatched to I-471 for a call of a person trying to jump out of a moving vehicle in order to harm himself. Officer Laffin was the first to arrive on the scene, and located the caller and the passenger on the side of I-471. As Officer Laffin pulled up, he saw that a woman and man were out of their car on the shoulder of the highway, and that the woman was trying to hold back the man to prevent him from running out into highway traffic. As Officer Laffin was getting out of his vehicle, the man pulled away from the woman and tried to run out into the highway. Officer Laffin reacted quickly and physically prevented this man from entering traffic. In doing so, Officer Laffin had to place himself in harm's way, as he was in the right lane of traffic. Officer Laffin undoubtedly saved this man's life.

ENFORCEMENT:

In February, officers wrote 17 speeding charges, 20 charges for non-traffic offenses (i.e., warrants, assaults, disorderly conduct, etc.) and 73 traffic charges (i.e., suspended OL, no insurance, expired license plate, etc.) Officers also issued 81 written warnings and totaled 12 court appearances. There were 19 drug related charges placed against 12 adults and two drug charges placed against one juvenile. Four of the individuals are Fort Thomas residents. Traffic stops led to 11 of the charges.

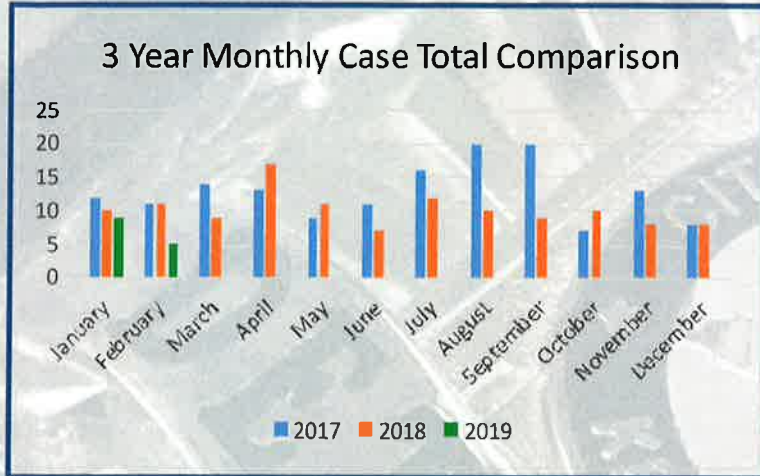
